**THIS QUIT CLAIM DEED**, made and entered into this the 8<sup>th</sup> day of November,

2010, by and between **BARBARA L. MOODY WOOD**, party of the first part; and **CFR LAND**

**HOLDINGS, LLC**, a Florida Limited Liability Company, party of the second part;

**WITNESSETH:**

**THAT**, for and in the consideration of the sum of **ONE DOLLAR (\$1.00)**, and other valuable consideration, the receipt of all of which is hereby acknowledged, the party of the first part does hereby grant, sell and convey unto the party of the second part all of her right, title and interest in and to that certain parcel of real property located in Jumping Branch District, Summers County, West Virginia, described as follows:

BEGINNING at a rock in Little Bluestone a corner to Gott, thence with one line of same S 25° 15' 61 poles to a white oak dogwood, a corner to Hopkins survey and with same 32° E 20' \_\_\_ poles to a chestnut and sourwood S 66° W 30 poles to a water oak sapling by a fence on a ridge, S 52° W 49 poles to a maple in a hollow, and leave the fence and run down the hollow with the meanderings thereof N 50° W 24 poles; N 64° W 25 poles to two sourwoods a Little Bluestone, thence down same same with its several meanderings thereof 90 poles to the place of BEGINNING, and containing 26 acres, more or less.


